Purchasing the Virtue Flat Range from BLM

The Club is currently waiting for BLM response to our application to purchase the Virtue Flat Range. The Club recently mailed a letter to BLM with recommendations for land classifications that will be conducive to completing the purchase transaction.

So far in 2012, the Club has received almost \$2500 in member donations to the Range Purchase fund. Special thanks to Herman and Eleanor Dopp for their \$1000 donation to the fund! As long-time members and prior Club Officers, the Dopps hope other members share their enthusiasm for purchase of the range, and they challenge PRSC members and the Baker County community to rise to this opportunity with donations to the purchase fund.

High Power Sporting Rifle Matches

The first HPSR match this year will be held May 6 starting at 8:30AM.

Sporting Rifle is a fun and challenging event that requires no special equipment. The competitor needs only a centerfire rifle with a capacity of 4 rounds, with a total weight including sights of 9.5 lbs or less. Standard High Power Bullseye Targets are placed at 200 yards from the firing line. These targets have a 13" aiming black, with a 7" 10-ring and a 3" X-ring. The 8-ring is white and 19", and the outer scoring diameter is the 5-ring at 37".

The course of fire is 2 sighting shots followed by 32 shots for record, as follows:

- > 8 shots prone with sling, fired within 10 minutes
- > 8 shots standing, offhand, fired within 8 minutes
- > two 4-shot strings seated with sling, each string fired within 30 seconds
- $>\,$ two 4-shot strings prone with sling, each string fired within 30 seconds

Targets are pulled and marked after each shot in the slow-fire stages and after each string in the rapid-fire stages. A perfect score would be 320-32X where each of the 32 shots for record struck the x-ring.

A 320 score can be accomplished if all shots are within the 10-ring.

Our Club originated NRA Sporting Rifle matches in Oregon many years ago, and we would like to see participation increase again. Our teams have done well in Sporting Rifle League Matches in prior years, so come out and join a team and shoot some matches with us! The standard team size is 6 shooters per team, and each team submits their 4 highest scores per match.

The Club is also hosting the Oregon State Sporting Rifle Championship on August 11-12. We have need of 4 volunteers not shooting the match to serve as line boss, pit boss, and scorekeepers.

YHEC

The Oregon Youth Hunter Education Challenge State Event will be held June 2 and 3 at Redmond. The local group led by Glenda Staebler-Siewell and Buck Buckner has been studying and practicing for the 4 shooting events and 4 responsibility tests. The top 5 scorers at the State Event in both the Junior and Senior categories will earn an expense-paid trip to the National YHEC competition in Pennsylvania in July. Local members Brian Staebler-Siewell and Nick Vowell both earned a spot on the 2011 Senior Team which placed 3rd at Nationals.

Wallowa Whitman Travel Management Plan

In response to significant public pressure, Forest Supervisor Monica Swalbach recently withdrew her TMP decision that would have closed almost 4000 miles of roads within the Wallowa Whitman.

Prior to that action, the Club had solicited an email vote from its members as an initial step in determining whether and how the Club would participate in the TMP appeal process. Only 27 responses were received: 11 voted for no road closures of any kind, 15 voted for some closures in a less restrictive plan, and 1 voted for the TMP as written. The reason most often cited by those who voted for some road closures was too many roads crossing hunting habitat.

The Club encourages all members to continue to participate in this process.

VIRTUE FLAT RANGE USE POLICIES

The Club makes every attempt to maximize the amount of time that the range is available for general use while also scheduling enough events and private range reservations to support operation of the range. Be sure to check the calendars in the newsletter or online before planning a trip to the range. When no events or reservations are scheduled, time of arrival establishes range use priority. If shooters are at the range prior to your arrival, their activities determine which ranges are available for use. In many cases, a shooting activity on one range does not affect other range use.

<u>The 1000-yard Range</u> prevents any other range use. This firing berm nearest to the entry gate is used for Black Powder Cartridge Rifle Silhouette Matches, Steel Silhouette Matches, 1000-yard Benchrest Shoots, and long-range High Power Rifle Matches. Before firing from this range, shooters must first check the entire range to be sure no one else is down-range at any location east of the 1000 yard berm.

<u>The 200-yard Range</u> prevents use of the 1000-yard range. Most range use occurs here. Target holders are placed at 25, 50, 100 and 200 yards. This range is used for Standard High Power and Sporting Rifle Matches, Pistol Classes, and by most individuals wanting to test loads or sight rifles. Use of this range still allows for safe use of the 100-yard pistol range.

<u>The Pistol Range</u> prevents use of the 1000-yard range. This range is used for pistol shooting, .22 Silhouette Matches, Junior .22, YHEC, and Cowboy Action Shoots. Two benchrests and target placements out to 100 yards are available. Use of this range still allows for safe use of the 200-yard range. After range use, be sure to install the slide rails to keep cattle out of the shooting area.

<u>The Action Pistol Bays</u> prevent use of the 1000-yard range, and may prevent use of the Pistol or 200-yard Rifle Ranges. Restrictions:

- 1.) No matches will be scheduled simultaneously in the Pistol Bays and any other range location.
- 2.) During Scheduled Matches on the Rifle Range or 100-yard Pistol Range, no firing is permitted in the Pistol Bays.
- 3.) During Scheduled Matches at the Pistol Bays, no use of the Pistol Range is permitted, no firing is permitted on the Rifle Range, and no person may access Rifle Range locations east (downrange) of the 200-yard berm.
- 4.) No firing is permitted in the pistol bays when persons are downrange of the 200 yard rifle benches.
- 5.) When no matches are scheduled, individuals or groups who wish to use the Pistol Bays must direct all fire in an eastward direction at the back berm of the bay they are using. Do not fire in any other direction. The 180° arc of fire is permitted only during scheduled Practical Shooting Matches.
- 6.) When no matches are scheduled, simultaneous informal use of the Pistol Bays and Rifle or Pistol Ranges is permitted under the following conditions:
 - a. Fire in the Pistol Bays is directed in an eastward direction only.
 - b. Rifle Range shooters must call for and receive a cease-fire in the Pistol Bays before engaging in any activity downrange from the 200-yard benches.
- 7.) Do not fire rifles at plate racks in the Pistol Bays.

All ranges: if you see someone checking fence or pushing cows on the hillsides downrange of the target areas, STOP FIRING until that person has completely cleared the hillside.

Report all acts of vandalism to the Sheriff's office as soon as discovered.

Powder River Sportsmen's Club Virtue Flat Range Rules

- 1. Keep entrance gates closed at all times.
- 2. Always keep firearms pointed in a safe direction.
- 3. Keep firearms unloaded until ready to shoot.
- 4. Know where others are at all times.
- 5. DO NOT fire from the 1000, 600 or 300 yard lines until you have physically checked all downrange facilities and determined that there are no other persons downrange.
- 6. Do not use bottles or glass for targets.
- 7. Clean up after firing. It's your club help keep it clean!
- 8. Use trash receptacles, or better yet if you pack it in, pack it out!
- 9. DO NOT share the gate combinations with non-members.
- 10. Eye and ear protection is strongly recommended, and is required for all minors.
- 11. Failure to comply with rules will result in termination of membership.
